This information can facilitate the development of essay examination questions as well as serve as the basis for classroom discussions. ### **Test Bank of Multiple-Choice Questions**

As experienced instructors we are very much aware of the considerable time and effort needed to develop a test bank of good multiple-choice examination questions. Therefore, in an effort to reduce or eliminate this task for instructors, we have developed numerous multiple-choice questions which are based upon each of the chapters in the book. We know that as class

sizes continue to grow instructors increasingly choose to use this method of testing for their students. Each question is not only accompanied by the correct answer but also identifies the chapter where the question was drawn from and the page number in the book where the correct answer can be found. Thus if any of these questions are used in an examination and students challenge whether they are correct (which some will invariably do) the instructor can merely go to the book and show the student precisely where the correct answer can be found.
